

Beach Card 2022 regulations

Bottega Verde In the following European countries (Austria, Belgium, Czech Republic, Greece, Croatia, Spain, Germany, Denmark, France, Hungary, Ireland, Luxembourg, Latvia, Netherlands, Poland, Portugal, Sweden and Slovakia) to organise a Reward Promotion, **valid from 28 March to 31 August 2022**, named: “*Beach Card Web*”.
